For example, it seems that since Creative Commons can cover both content and the database, there is little need for the ODbL license. It would have been good to have some concrete examples of when the ODbL license would be preferable.

Finally, there was a lot of discussion around the idea that "data", which I think means individual data points do not have IP protection. However, I think it is more common to talk about data as "data sets", which it seems at least in the EU do have IP protection. This took a lot of discussion time, and at least to me did not seem to really be important for understanding the licenses.
